**About ASWA**

The American Society of Women Accountants (ASWA) was organized by The American Women's Society of Certified Public Accountants (AWSCPA) in 1938 to further the interest of women in all fields of accounting. Today, an additional objective is to assist women in re-entering the accounting profession and to provide a networking base that supports the needs of professional women.

**Mildred Dahl Scholarship Fund**

The Mildred Dahl Scholarship Fund was founded in 1971 by the members of the Minneapolis-St. Paul Chapter of ASWA and is financially supported by donations solicited from Chapter members and local employers. The Fund's purpose is to provide scholarships to women undergraduate students majoring in accounting.

Since its formation, the Trustees of the Funds have awarded annual scholarships in varying amounts. In the past two years, we awarded scholarships from \$500 to \$800 to deserving students. This year the Trustees will again be reviewing applications to award one or more scholarships depending on the number of applications received.

Applicants should be women who have demonstrated academic excellence, leadership, and service to their community. Financial need will receive particular attention and to personal circumstances. This year, the Trustees encourage both traditional and non-traditional age students to apply. Mildred Dahl scholarships may be used toward tuition, books, and other education related expenses incurred during the school year.
